DIRECTIONS - Longwood

From 1-4 heading EAST or WEST: Take exit #94 Longwood to head West onto S.R. 434. Go approximately 1.7 miles and on your right is 2855 West S.R. 434, across from the Oak Grove Shoppes. Mid-Florida Endodontics is in Suite 1021.

DIRECTIONS - Maitland

From I-4 heading EAST/WEST: Exit at 90A to Eastbound Maitland Blvd (SR 414). Continue straight and pass through the Maitland Ave/Maitland Blvd intersection. Stay to the right and follow the sign for 17-92 South-West. At the next traffic light, turn right onto 17-92 South-West. Pass the Maitland Sunrail (right) and Mercedes dealership (left). Turn left into Maitland Exchange office complex.

Once in the complex, turn left. Our ENDODONTICS office is Suite 203 on the 2nd floor, elevator button 3. Parking is available in the front and rear of the building; an elevator is located in the center.

DIRECTIONS - Waterford Lakes

From S.R. 408 heading EAST: Take exit #21 (Alafaya Trail). Turn right onto N. Alafaya Trail and immediately get into the far left lane. At the first traffic light, make a left onto Lake Underhill Road. Take the first left into the Park at Waterford Lakes plaza entrance. Mid-Florida Endodontics is in Suite 104, next to Bonefish Grill.

From FL 50/E Colonial Drive heading WEST: Turn left onto N. Alafaya Trail and after approximately 1.5 miles, get into the far left lane to make a left at the traffic light onto Lake Underhill Road. Take the first left into the Park at Waterford Lakes plaza entrance. Mid-Florida Endodontics is in Suite 104, next to Bonefish Grill.

DIRECTIONS - Kissimmee

From the FL Turnpike: Take exit #249 to head East onto Osceola Parkway. After approximately 1 mile, make a right into the Ventura Downs/Publix Sabor plaza. If you reach Buenaventura Blvd., you've gone too far. Mid-Florida Endodontics is next to Subway.

From S.R. 417: Take exit #14 Landstar Blvd to head South for 1.5 miles. Turn right onto East Osceola Parkway and after approximately .5 miles, make a U-turn to head back to the entrance to Ventura Downs/Publix Sabor plaza. Mid-Florida Endodontics is next to Subway.

DIRECTIONS - Orange City

From 1-4 East or West: Take exit #111B and merge onto Saxon Blvd, heading west. Drive approximately 1 mile (pass Florida Hospital) and make a left onto Enterprise Road. Mid-Florida Endodontics is less than 1 mile down the road on left in the Orange City Town Center. Office Suite 211 is located on 2nd floor.

DIRECTIONS - Daytona Beach

From 1-4: Take 1-4 East to exit #132 FL-400E (South Daytona). Continue on FL-400E/Beville Rd through one stop light until the blue "Professional Village" sign is visible on right. Turn right at blue sign into complex. Take an immediate left, our office is in first building on the left. Entrance on south side of building under breezeway.

From 1-95: Take exit #260A FL-400E (South Daytona). Merge onto FL-400E/Beville Rd. Continue on FL-400E/Beville Rd through one stop light until the blue "Professional Village" sign is visible on right. Turn right at blue sign into complex. Take an immediate left, our office is in first building on the left. Entrance on south side of building under breezeway.
